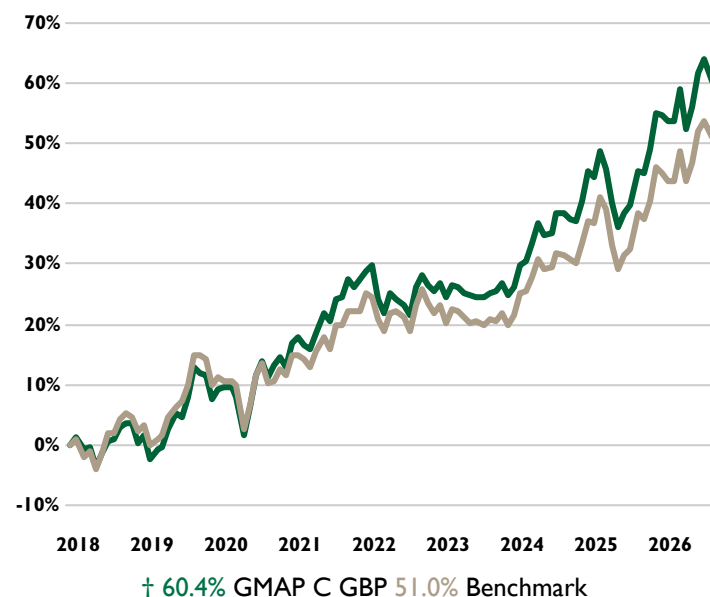

PORTFOLIO COMMENTARY

The fund declined in July, as did its benchmark. Markets experienced a volatile month as investors balanced strong corporate earnings against concerns over inflation, energy prices and the outlook for AI-related investment. Equities sold off initially as sentiment weakened amid concerns over AI demand and tighter export controls on advanced semiconductor technologies. These declines were partially reversed by the strong start to the second quarter earnings season later in the month. UK and European equities delivered positive returns, while US, Japanese and Emerging Market equities declined. Fixed income markets also struggled, with government bond yields rising as investors scaled back expectations for near-term rate cuts.

Within equities, our more defensive managers delivered strong performance, including Independent Franchise Partners (IFP), Prusik Asian Equity Income and Sector Healthcare. IFP benefited from its lower allocation to technology stocks, which sold off during the month for the reasons outlined above. Similarly, Sector Healthcare benefited from its lack of exposure to the weaker areas of the market, while its pharmaceutical holdings were supported by strong earnings. Among the detractors, several strategies that had performed strongly earlier in the year reversed course in July, including Veritas Asia and Driehaus US Small Cap. Veritas remains significantly ahead of its benchmark year to date; however, its high-conviction exposure to technology weighed on performance during the month following the sell-off in Korean and AI infrastructure-related stocks.

Fixed income was weaker in absolute terms during July, though most holdings outperformed their benchmarks on a relative basis. Alternative performance was mixed. The Fermat Cat Bond Fund delivered positive returns, with US and European wildfires and an earthquake in Japan having no impact on the catastrophe bond market. Conversely, the MW TOPS Focus Fund detracted. Sharp sector rotations saw its long technology positions fall while the outperformance of consumer staples and energy weighed on its short book.

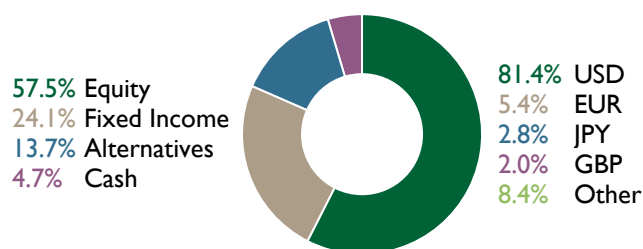

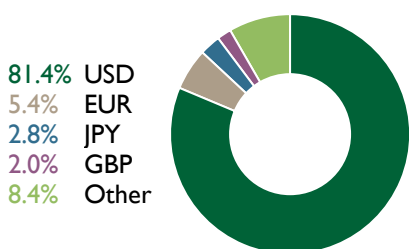

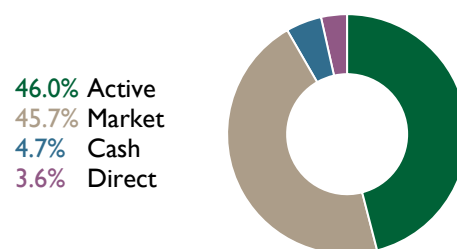
