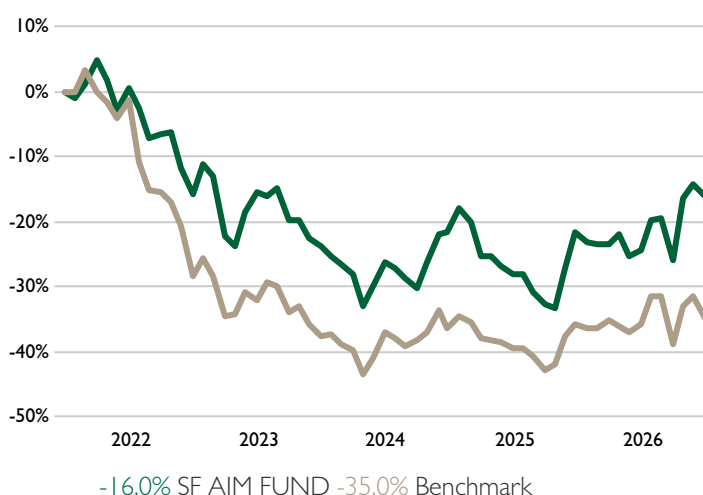

FUND COMMENTARY

Economic news was positive during the month, supported by the short-term ceasefire between the US and Iran and hopes of a permanent peace agreement. Some traffic has resumed through the Strait of Hormuz, and the retreat in oil and gas prices is helpful. UK inflation held steady at 2.8%, down from 3.3% in March, prompting the Bank of England's Monetary Policy Committee to keep interest rates unchanged at 3.75%, with the 2% long-term target still achievable. Politically, Prime Minister Starmer's resignation was unsurprising, and Andy Burnham looks set to take over after winning the Makerfield by-election. A change of Chancellor appears inevitable, although indications suggest the current fiscal rules will remain in place. If so, the government will need to find funding for the £4.7 billion shortfall created by higher spending following the publication of the UK Defence Investment Plan.

We participated in Portmeirion's share placing to establish a new holding. The Stoke-on-Trent tableware company raised £17 million to refinance borrowings, support US expansion and fund potential bolt-on acquisitions with a brand refresh. Its brands include Portmeirion, Spode and Royal Worcester, which the new management team believes can deliver profitable growth. We sold our holding in Huddled, the online food retail business, due to the small size of our position, and adjusted several other holdings. As investor confidence continues with UK large caps and smaller companies, specialist fund managers are likely to benefit from rising assets under management and, in turn, improved profitability. It remains to be seen how a change of prime minister and cabinet will affect government policy, but the stock market is showing little concern, and we remain comfortable with the portfolio's holdings.
