FUND COMMENTARY

Global equity markets ended July broadly flat and still near record highs. Markets rebounded strongly near month-end, to the effect that the losses witnessed earlier in the month were effectively cancelled out. The crude oil price ended the month over 20% higher, having briefly been above \$100 a barrel intra-month as tensions between the US and Iran reignited. Weakness in memory and semiconductor-related stocks was a notable feature. While Western memory companies have been reporting record profits, market anxiety around the sustainability of these profits has grown given new capacity being added and the risk of heightened Chinese competition. A new Chinese AI model, Kimi K3, also contributed to concerns over the business models of the AI labs. Some nervousness remains around the financing of the AI infrastructure buildout, including off balance sheet structures.

The recovery in markets towards month end was helped by a strong second-quarter S&P 500 earnings season, with around 88% of companies that have reported so far exceeding earnings expectations. Aggregate revenue growth of nearly 15% YOY surpassed expectations by over three percentage points. The three large US hyperscalers all reported accelerating growth in their cloud businesses, helping to boost investor confidence on the likely return on their substantial capex. Portfolio holdings Microsoft and Amazon reacted particularly positively to their results.

The strongest contributors to the Fund's performance in July were Microsoft, Mastercard and Cintas. Microsoft reported strong Q2 results, which included an accelerating YOY revenue growth for the Azure cloud business and a large sequential increase in paid CoPilot subscribers. Mastercard reported an excellent set of Q2 results, with net revenue rising more than 14% supported by a recovery in international travel. Cintas delivered a strong quarterly earnings beat, robust fiscal 2027 guidance, and solid growth across its core segments.

Detractors included KLA, ASML and Cadence Design Systems, which were affected by the general weakness in semiconductors despite all three reporting strong Q2 results.

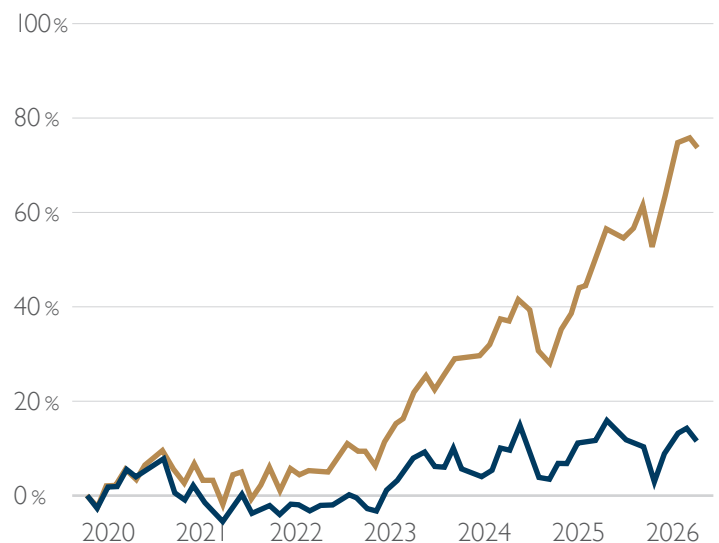

OUTCOME OF FAIR VALUE ASSESSMENTS (2025)

- The fund meets the needs of the target market.
- The intended distribution strategy remains appropriate.
- Historically, the fund did not deliver value for money. In response, as of the 2nd August 2023, Stonehage Fleming Investment Management Limited changed the personnel managing the fund and the approach to investment selection. The fund will follow the strategy pursued by the Stonehage Fleming Global best ideas fund (GBI), and own the same quality growth business as this fund. INVESTOR PROFILE

The fund is appropriate for all investor types, including those with only a basic knowledge of funds.
